






These instructions assume that you do not have a PayPal account; if you do, you will probably be familiar with how it works


5. On the PayPal screen, enter your email address and then select [Pay by Debit or Credit Card] - <u>DON'T select [Next]</u>

6. Enter your email address again and select [Continue to Payment]






7. Enter your contact details and payment card information
